

## **BPP Training and Preparatory Sessions**

Advocacy Training	Three days	<ul> <li>Friday: all day lecture which considers each component (Civil Application, Examination in Chief and Cross-Examination).</li> <li>Opportunity for Q&amp;A with tutor.</li> <li>Saturday: all day practical training, comprising of three, two-hour sessions which provide a forum for discussion of each oral skill and allow candidates the opportunity to practise and receive feedback.</li> </ul>

Professional Ethics	One day Two hours	<ul> <li>Professional Ethics Lecture: candidates will go through the Professional Ethics syllabus with a tutor. Includes teaching, group work and completion of individual exercises, allowing candidates to improve their understanding of various aspects of the syllabus.</li> <li>Professional Ethics Webinar: candidates have the chance to ask questions and clarify discrete areas of the Professional Ethics syllabus.</li> </ul>
Criminal Litigation	One day Two Hours	Criminal Litigation Lecture: candidates go through the Criminal Litigation and Sentencing syllabus with a tutor. Includes teaching, group work and completion of individual exercises, allowing candidates to improve their understanding of various aspects of the syllabus and engage with the multiple-choice question format. Criminal Litigation Webinar: candidates have the chance to ask questions and clarify discrete areas of the Criminal Litigation and Sentencing syllabus.
Opinion Writing and Legal Research (whilst these are two separate modules, we recommend studying them together as the assessments take place at the same time)	Four hours (x2 two-hour sessions)	<ul> <li>Opinion Writing and Legal Research Workshop: each session is spaced approximately one week apart. Candidates learn how to construct an effective legal research trail and structure a legal Opinion so that it is comprehensive and client friendly, dealing with both facts and law.</li> <li>Mock Opinion Writing Assessment: candidates may also submit a mock or formative assessment, with personalised feedback from a tutor against assessment marking criteria.</li> </ul>
Drafting	Four hours (x2 two-hour sessions)	Drafting Workshop: each session is scheduled approximately one week apart. Candidates learn about drafting a statement of case including structural formalities and legal requirements across the different documents.         Mock Drafting Assessment: candidates may also submit a mock or formative assessment, with personalised feedback
Conference Skills	Four hours (x2 two-hour sessions)	from a tutor against assessment marking criteria. Conference Skills Workshop: each session is scheduled approximately one week apart. Candidates have the chance to discuss key elements of the assessment criteria and to practise the skills involved in conducting a successful conference with a client.
