BAR STANDARDS BOARD RESPONSE: THE OFFICE FOR LEGAL COMPLAINTS/LEGAL OMBUDSMAN DRAFT STRATEGY AND BUSINESS PLAN 2024/27

Strategic objective for LeO's service and 2024/25 plans

1. Do you support the OLC's draft strategic objective for LeO's service and supporting aims? What would success look like to you as we move from 2024 to 2027?

- 1. The Bar Standards Board (BSB) welcomes and supports the OLC's service oriented strategic objective and aims for LeO.
- 2. The ambitions that LeO services are efficient and proportionate, provides high quality outcomes and is accessible are essential elements for resolving consumer complaints effectively.
