Bar Training Civil Litigation Syllabus 2021-2022 Summary of Changes

Introduction

We have been asked by the Bar Standards Board to provide a short document summarising the main changes to the Bar Training Civil Litigation Syllabus in 2021-2022. This document is particularly intended to enable second year part time students to understand which areas of the 2020-2021 syllabus will form part of the centrally set assessments in 2021-2022, and which parts of the 2020-2021 syllabus will not be assessed.

This document provides a summary of the main changes to the syllabus. Students should also refer to the new syllabus, which includes full updated references to 'Civil Procedure' (the White Book) 2021 and The Jackson ADR Handbook (Third Edition, 2021), to understand the detailed requirements of the 2021-2022 syllabus.
